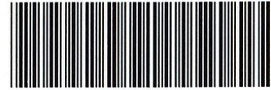

OCCUPANTS OF THE AUDI INTO CUSTODY. DETECTIVE , POSITIONED ; UNMARKED POLICE VEHICLE IN FRONT OF THE AUDI AS OTHER OFFICERS APPROACHED THE VEHICLE ON FOOT FROM DIFFERENT ANGLES. OFFICERS WERE WEARING BADGES, UNIFORMS, POLICE INSIGNIAS, AND HAD THEIR FIREARMS DRAWN. OFFICERS ISSUED LOUD VERBAL COMMANDS TO THE DEFENDANT AND JL. AS OFFICER GAVE VERBAL COMMANDS FOR THE DEFENDANT TO EXIT THE AUDI, THE DEFENDANT MOVED FROM THE REAR PASSENGER SEAT AND SAT IN THE DRIVER'S SEAT. JL COMPLIED WITH COMMANDS FROM OFFICERS AND EXITED THE AUDI USING THE RIGHT REAR DOOR. THE DEFENDANT THEN PLACED THE AUDI IN DRIVE AND ACCELERATED AT A HIGH RATE OF SPEED WHILE TURNING THE STEERING WHEEL TO THE LEFT. THE DEFENDANT'S ACTIONS AS HE ATTEMPTED TO FLEE CAUSED THE AUDI TO DRIVE IN THE DIRECTION OF DETECTIVE . UNMARKED VEHICLE AND CRASHED INTO IT'S RIGHT PASSFNGER DOORS. VIDEO FOOTAGE SHOWS DETECTIVE . TAKING COVER BEHIND ; UNMARKED VEHICLE AND THEN CHANGING TACTICAL POSITION TO AVOID BEING STRUCK. THE DEFENDANT THEN MANEUVERED THE AUDI IN THE DIRECTION OF OFFICERS AND CRASHED INTO A GARAGE PILLAR AND A PARKED VEHICLE (SILVER BUICK LACROSSE, FL TAG# THE IMPACT WAS SO SEVERE THAT IT CAUSED THE AUDIS AIRBAG TO DEPLOY. THE DEFENDANT ALSO STRUCK DETECTIVE ON LEGS AND BACK WHEN HE ACCELERATED THE VEHICLE IN DIRECTION. SEVERAL OFFICERS DISCHARGED THEIR FIREARMS WHILE THE AUDI WAS BEING DRIVEN AT THEM, DEMOSTRATING A WANTON DISREGARD FOR THEIR SAFETY. THE DEFENDANT WAS TREATED ON SCENE FOR HIS INJURIES AND TRANSPORTED TO HOSPITAL BY MIAMI DADE FIRE RESCUE. DETECTIVE WAS ALSO TRANSPORTED TO BY MIAMI DADE FIRE RESCUE DUE TO INJURIES CAUSED BY THE INCIDENT. DURING A SWORN INTERVIEW, JL STATED THAT WHILE IN THE REAR SEAT OF THE AUDI, THE DEFENDANT BECAME ALERTED TO POLICE PRESENCE. JL STATED SHE TOLD THE DEFENDANT TO COMPLY, BUT HE MOVED TO THE DRIVERS SEAT OF THE AUDI. AS SHE EXITED THE VEHICLE, SHE OBSERVED THE DEFENDANT TURNING THE STEERING WHEEL, AIMING THE VEHICLE, AND ACCELERATING AT THE OFFICERS. A FIREARM WAS SEIZE FROM THE AUDI. THE DEFENDANT INVOKED HIS CONSTITUTIONAL RIGHTS AND DID NOT GIVE A STATEMENT. THE DEFENDANT'S MOTHER WAS NOTIFIED OF HIS CONDITION AND ADVISED HE WAS IN CUSTODY. THE DEFENDANT WAS ARRESTED WHILE ADMITTED TO THE THE JAC WAS CONTACTED AND ... [Continued on Next Page]													


