

RESOLUTION NO. 2019-R-003

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF MAYTIN ENGINEERING CORP., AS THE LOWEST, RESPONSIVE AND RESPONSIBLE CONTRACTOR TO PERFORM THE CLEARING AND GRUBBING PROJECT AT THE FORMER PEPPER LAKE SITE, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 69-17-18; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH MAYTIN ENGINEERING CORP., FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED EIGHTY-SIX THOUSAND TWO HUNDRED NINETY-SIX DOLLARS (\$86,296.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on October 10, 2018, the City of North Miami (“City”) advertised *Invitation for Bid No. 69-17-18 –Clearing and Grubbing Project at the Former Pepper Lake Site* (“IFB”), requesting bids from experienced and qualified contractors to furnish all labor, equipment, materials and expertise needed for the clearing and grubbing project at the former Pepper Lake Site; and

WHEREAS, pursuant to the IFB, the selected contractor is required to provide all necessary labor, equipment, materials and expertise required for the implementation and completion of the project including, but not limited to: providing clearing and leveling services for an approximately 250,000 square feet site with approximately 8,000 tons of material of various size and types of concrete rubble, general demolition and site grubbing and disposition of metal materials at the former Pepper Lake Site (“Services”); and

WHEREAS, in response to the IFB, the City received and opened six (6) bids and Maytin Engineering Corp. (“Contractor”), was determined to be the lowest responsive and responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, in accordance with City administration’s ranking, the City Manager respectfully requests that the Mayor and City Council approve the selection of the Contractor, as the lowest, responsive-responsible bidder in the provision of Services, and authorize the City

Manager and City Attorney to negotiate and execute an agreement at a cost not to exceed Eighty-Six Thousand Two Hundred Ninety-Six Dollars (\$86,296.00); and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interest to approve the selection of Contractor and hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Selection Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the City administration's ranking and selection of Maytin Engineering Corp., as the lowest, responsive and responsible contractor to perform clearing and grubbing project at the former Pepper Lake Site, in accordance with the terms, conditions and specifications contained in *IFB No. 69-17-18 –Clearing and Grubbing Project at the Former Pepper Lake Site.*

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services with Maytin Engineering Corp., at a cost not to exceed Eighty-Six Thousand Two Hundred Ninety-Six Dollars (\$86,296.00), and a project completion timeline of 120 days from the City's issuance of Notice-to-Proceed ("NTP").

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
