**Requests for Clarifications/Questions Received**

**Q.1** Given that we are dealing with live plant material—specifically trees that must meet exact species, grades and standards, height, spread, and caliper specifications—and considering that trees are not manufactured, availability can vary due to seasonality, nursery inventory, and the timing of the bid award (e.g., 30, 45, or 60 days from now). In the event that the specified material is not available now or at the time of installation, how should we proceed? Please do not refer us back to the bid specifications stating that substitutions are not allowed, as that does not address situations where the specified plant material is no longer available in the market. We are seeking practical guidance that allows us to maintain the integrity and intent of the project while responding to real-world availability. From bid opening to award could be 30 days or more, what's available today is no guarantee It will be available 30 days from now.

**A.1** There are a multitude of nurseries to locate trees that meet the various specifications (e.g. species, grades, and standards, height, spread, and caliper) required to fulfil the project. Trees for this project were previously approved by Miami-Dade County; thus no exceptions can be made.

**Q.2** What is the city dollar amount budget number for this project?

**A.2** **\$80,250**

**Q.3** If the City provides a response to a question that does not clearly address the concern or leaves ambiguity, will vendors be allowed to submit a follow-up question for clarification—even if the official question deadline has passed?

**A.3** **No, the City is confident that the responses provided are correct, accurate, and thorough. Therefore, the deadline for the submission of questions and clarifications will not be extended**

**Q.4** Will the city be contacting all the homeowners whose addresses are scheduled to receive trees to verify they want the tree?

**A.4** **The City has distributed door hangers that included information about the project and how to opt-out of receiving a tree if they choose. The hangers are translated in English, Spanish, Haitian Creole. As of 7/31/2025, there have been 4 opt-out requests received.**

**Q.5** Since the trees will need to be watered about 40 times or more at the contractors expense, will the city provide the water or a water source?

**A.5** **The City is unable to provide water or a water source.**
