

RESOLUTION NO. 2019-R-004

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF TIMMONS GROUP, INC. TO PROVIDE GIS SERVICES FOR THE CITY, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN REQUEST FOR PROPOSALS NO. 67-17-18 GEOGRAPHIC INFORMATION SYSTEM ("GIS") SERVICES; FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH TIMMONS GROUP, INC. FOR A THREE (3) YEAR TERM WITH TWO (2) OPTIONS TO RENEW FOR A ONE (1) YEAR PERIOD; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on August 15, 2018, the City of North Miami ("City") advertised *Request for Proposals No. 67-17-18 Geographic Information Services* ("RFP"), for the purpose of seeking proposals from experienced and qualified firms to provide professional Geographic Information Systems ("GIS") services for the City, in accordance with the terms, conditions and specifications contained in the RFP ("Services"); and

WHEREAS, in response to the RFP, Timmons Group, Inc. ("Vendor"), submitted its proposal and was subsequently evaluated by the Evaluation Committee as the highest ranked firm, whose qualifications and references demonstrated to be the most advantageous to the City in the procurement of Services; and

WHEREAS, the Vendor has expressed its capability, expertise and willingness to perform the Services pursuant to RFP requirements, for an initial term of three (3) years with two (2) options to renew for one (1) year periods, at the discretion of the City Manager or designee; and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interest to approve the selection of Vendor and authorize the City Manager to execute an agreement with Vendor for the provision of Services.


NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Selection Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of Timmons Group, Inc., in accordance with the terms, conditions and specifications contained in Request for Proposals No. 67-17-18 Geographic Information System Services, to provide GIS services to the City.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to execute a professional services agreement with the selected Vendor for an initial term of three (3) years with two (2) options to renew for one (1) year periods, at the discretion of the City Manager or designee.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
