

RESOLUTION NO. 2025-R-158

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF
THE CITY OF NORTH MIAMI, FLORIDA, DECLARING NO
OBJECTION AND SUPPORTING THE HONORARY CO-
DESIGNATIONS BY THE FLORIDA LEGISLATURE
DESIGNATING FLORIDA TRANSPORTATION FACILITIES
("ROADWAYS") LOCATED WITHIN THE CITY OF NORTH
MIAMI, PURSUANT TO SENATE BILL 820; PROVIDING FOR
AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, Florida Statute 334.071 entitled "Legislative Designation of Transportation Facilities" states that erection of markers shall be contingent upon the appropriate city or county commissioner passing a resolution in support of the particular honorary designation; and

WHEREAS, pursuant to the request made by the Florida Legislature for honorary designation of roads located within the City of North Miami ("City"), the Mayor and City Council have no objection to the honorary designations and support Senate Bill 820; and

WHEREAS, Senate Bill 820, adopted by the Florida Legislature and approved by the Governor on June 20, 2014, and codified under Chapter 2014-228 of the Laws of Florida, designated state transportation facilities ("roadways") that are located within the City as follows:

- (1) That portion of N.E. 8th Avenue between S.R. 916/N.E. 135th Street and N.E. 131st Street in Miami-Dade County is designated as "Gerbuns Augustin Avenue."; and
- (2) That portion of S.R. 922/N.E. 125th Street between N.E. 8th Avenue and N.E. 9th Avenue in Miami-Dade County is designated as "Sergeant Carl Mertes Street."; and
- (3) That portion of N.E. 126th Street between N.E. 8th Avenue and N.E. 9th Avenue in Miami-Dade County is designated as "Detective Sergeant Steven E. Bauer Street."; and
- (4) That portion of N.E. 127th Street between N.E. 8th Avenue and N.E. 9th Avenue in Miami-Dade County is designated as "Sergeant Lynette Hodge Street."

WHEREAS, the underlying legislation directs the Florida Department of Transportation ("FDOT") to erect suitable markers for these street designations; and

WHEREAS, the Interim City Manager respectfully requests that the Mayor and City Council declare no objection and support the aforementioned honorary co-designations by the State of Florida Legislature.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Approval of Street Co-Designation.** The Mayor and City Council of the City of North Miami, Florida, hereby declare no objection and support the honorary co-designations by the Florida Legislature designating Florida Transportation Facilities ("Roadways") located within the City of North Miami, Pursuant to Senate Bill 820.

Section 2. **Directions to City Clerk.** The City Clerk shall forward a copy of this Resolution to the Florida Department of Transportation ("FDOT") and to the appropriate officials of Miami-Dade County.

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
