

RESOLUTION NO. 2025-R-157

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, ESTABLISHING THE CITY OF NORTH MIAMI RESIDENTIAL HAZARDOUS TREE TRIMMING AND REMOVAL PROGRAM AND APPROVING THE PROGRAM GUIDELINES, ATTACHED AS EXHIBIT "A"; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") is desirous of establishing a Residential Hazardous Tree Program to provide tree trimming and/or removal services to income-qualifying homeowners in the City; and

WHEREAS, the City has established guidelines for the implementation of the Residential Hazardous Tree Program attached hereto as Exhibit "A"; and

WHEREAS, in accordance with the program guidelines, the tree or limb must present a danger to the homeowners' or adjacent neighbor's primary residence and show obvious signs of rot or damage; and

WHEREAS, funding is based on availability and will be provided on a first-come, first-served basis; and

WHEREAS, all services provided under this program will be conducted by a licensed and insured contractor provided by the City; and

WHEREAS, the program guidelines specify that the total household income must not exceed 120% of the Area Median Income (AMI) for Miami-Dade County, based on the most recent HUD income guidelines, and the property must be free of any outstanding code violations, judgment liens, or delinquent property taxes.

WHEREAS, the Mayor and City Council desire to implement the Residential Hazardous Tree Program to assist qualified households with tree trimming and/or removal services.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of the Residential Hazardous Tree Program Guidelines. The Mayor and City Council hereby approve the Program Guidelines attached as Exhibit "A".

Section 2. Authority of Interim City Manager. The Interim City Manager is authorized to implement said program in accordance with the approved.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
