

RESOLUTION NO. 2025-R-155

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE A GRANT AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (“FDEP”), TO SECURE A GRANT IN THE AMOUNT OF FOUR HUNDRED THOUSAND DOLLARS (\$400,000.00), IN SUPPORT OF THE CITY OF NORTH MIAMI’S FLOOD MITIGATION PROJECT AT N.E. 3RD COURT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the Florida Department of Environmental Protection (“FDEP”); and

WHEREAS, the City has been awarded a grant in the amount of Four Hundred Thousand Dollars (\$400,000.00) with no required match for a total project cost in the amount of Four Hundred Thousand Dollars (\$400,000.00); and

WHEREAS, funds will be used toward a flood mitigation project along N.E. 3rd Court, between N.E. 131st Street and N.E. 135th Street; and

WHEREAS, the flood mitigation project includes the construction of an exfiltration trench, drainage structures, water main services, as well as relocation of existing sewer laterals on N.E. 3rd Court; and

WHEREAS, the Mayor and City Council wish to authorize the execution of an agreement for grant funds between the City and the Florida Department of Environmental Protection.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Ratification and Approval. The Mayor and City Council hereby ratifies the submission of an application and approves the acceptance of the grant from the Florida Department of Environmental Protection, in the amount of Four Hundred Thousand Dollars (\$400,000.00), in support of the City of North Miami’s Flood Mitigation Project on N.E. 3rd Court.

Section 2. Authority to Interim City Manager. The Interim City Manager is hereby authorized to execute an agreement between the City of North Miami, Florida, and the Florida Department of Environmental Protection.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
