

RESOLUTION NO. 2019-R-016

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO ENVIROWASTE SERVICES GROUP, INC., IN THE AGGREGATE AMOUNT NOT TO EXCEED SEVENTY-FIVE THOUSAND DOLLARS (\$75,000.00), FOR THE PROVISION OF STORMWATER DRAINAGE SERVICES, PIGGYBACKING CITY OF DORAL REQUEST FOR PROPOSALS NO. 2013-32; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on December 11, 2013, the City of Doral, issued *Request for Proposals No. 2013-32 – Catch Basin Maintenance Program* (“Solicitation”), seeking proposals from qualified and experienced vendors to provide Doral with stormwater drainage services; and

WHEREAS, in response to the Solicitation, Envirowaste Services Group, Inc. (“Vendor”) was determined to be the sole responsive and responsible proposer meeting or exceeding the solicitation requirements and was subsequently awarded a contract which is currently valid through September 30, 2020; and

WHEREAS, Section 7-167 of the City of North Miami (“City”) Code of Ordinances authorizes the City Manager to approve the purchase of supplies, goods and/or services from current agreements of other municipalities and governmental entities (“piggyback”), such as the City of Doral contract; and

WHEREAS, City administration is requesting the approval of the piggyback for the provision of stormwater drainage services in an amount not to exceed Seventy-Five Thousand Dollars (\$75,000.00); and

WHEREAS, the Mayor and City Council find the piggyback of the City of Doral contract with the Vendor for stormwater drainage services, in accordance with the Solicitation, is in the best interest of the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Envirowaste Services Group, Inc., in the aggregate amount not to exceed Seventy-Five Thousand Dollars (\$75,000.00), for the provision of stormwater drainage services, piggybacking the City of Doral, *Request for Proposals No. 2013-32- Catch Basin Maintenance Program.*

Section 2. Effective Date. This Resolution shall be effective upon adoption.
