

**RESOLUTION NO. 2025-R-153**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE INTERIM CITY MANAGER AND  
THE CITY ATTORNEY TO NEGOTIATE AND EXECUTE  
AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF  
NORTH MIAMI AND MIAMI-DADE COUNTY TO SECURE  
FUNDS FROM THE MIAMI-DADE RESCUE PLAN FUND  
IN THE AMOUNT OF TWO MILLION DOLLARS  
(\$2,000,000.00) TO BE USED TOWARD THE CAGNI PARK  
IMPROVEMENT PROJECT; FURTHER AUTHORIZING  
THE INTERIM CITY MANAGER TO TAKE ALL ACTION  
NECESSARY TO IMPLEMENT THE TERMS OF THE  
INTERLOCAL AGREEMENT; PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”), in partnership with the Miami-Dade County School Board, seeks to construct a multi-functional public park adjacent to North Miami Middle School and Arch Creek Elementary School (“Cagni Park Improvement Project”); and

**WHEREAS**, the City is currently implementing Phase I of the project with a scope of work that consists of construction of: an aquatic center with recreation/lap swimming pools and restroom/locker facility, synthetic turf multi-purpose football/soccer field including scoreboard, bleachers, and player benches, lighted surface parking lot, picket fencing, pedestrian walkways, landscaping and irrigation, playgrounds with shade and safety surfacing, and installation of site furniture such as benches, litter receptacles, drinking fountains, and bike racks; and

**WHEREAS**, on September 19, 2024, the Board of County Commissioners of Miami-Dade, Florida, adopted the FY 2024-2025 Operating Budget and Multi-Year Capital Plan, which approved a Two Million Dollar (\$2,000,000.00) allocation to the City of North Miami from the Miami Rescue for the Cagni Park Improvement Project; and

**WHEREAS**, through the Miami-Dade County Miami-Dade Rescue Plan Fund, the Cagni Park Improvement Project, will improve the capacity and quality of local recreational infrastructure, supporting wellness, youth programming, and community resilience; and

**WHEREAS**, the Mayor and City Council desire to authorize the negotiation, finalization, and execution of an Interlocal Agreement with Miami-Dade County for these purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA:

**Section 1. Authority of Interim City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an Interlocal Agreement with Miami-Dade County to provide for funding in the amount of Two Million Dollars (\$2,000,000.00) to be used toward the Cagni Park Improvement Project and further authorize the Interim City Manager to take all action necessary to implement the terms of the Interlocal Agreement.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
