

RESOLUTION NO. 2025-R-152

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AWARD AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT (“FDLE”), TO SECURE A GRANT IN THE AMOUNT OF NINE THOUSAND SIX HUNDRED EIGHTY-SEVEN DOLLARS (\$9,687.00), IN SUPPORT OF A COMPREHENSIVE HEALTH AND WELLNESS PLATFORM FOR LAW ENFORCEMENT PERSONNEL; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the Florida Department of Law Enforcement (“FDLE”); and

WHEREAS, the City of North Miami (“City”) requested a grant in the amount of Nine Thousand Six Hundred Eighty-Seven Dollars and No Cents (\$9,687.00) with no required match for a total project cost in the amount of Nine Thousand Six Hundred Eighty-Seven Dollars and No Cents (\$9,687.00); and

WHEREAS, funds will be used to implement a comprehensive health and wellness platform for the City’s law enforcement personnel; and

WHEREAS, the grant will fund the purchase of essential law enforcement equipment and implementation of a subscription-based health and wellness platform dedicated to supporting the mental health and resilience of its officers; and

WHEREAS, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the Florida Department of Law Enforcement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Ratification of Submittal of Application. The Mayor and City Council hereby ratify the submittal of the City of North Miami’s application for a grant from the Florida

Department of Law Enforcement (“FDLE”) in support of a comprehensive health and wellness platform for the City’s law enforcement personnel.

Section 2. Authority to Interim City Manager and City Attorney. The Interim City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida, and the Florida Department of Law Enforcement to obtain grant funds.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
