

RESOLUTION NO. 2019-R-018

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF LOU'S POLICE DISTRIBUTORS, INC., FOR THE PURCHASE OF LAW ENFORCEMENT UNIFORMS, EQUIPMENT AND ACCESSORIES, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN IFB #24-18-19; AND FURTHER AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS IN AN ANNUAL AMOUNT NOT NOT-TO-EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on January 8, 2019, the City of North Miami ("City") issued *Invitation for Bids # 24-18-19 – Law Enforcement Uniforms, Equipment & Accessories* ("IFB") requesting bids from qualified and experienced vendors to supply the North Miami Police Department ("NMPD") with Law Enforcement Uniforms, Equipment & Accessories (protective gear, holsters, handcuff cases, etc.) necessary in the performance of their duties; and

WHEREAS, in response to the IFB, the City received and opened two (2) bids on January 18, 2019; and

WHEREAS, Lou's Police Distributors, Inc. ("Vendor") was found to be the most responsive and responsible bidder, demonstrating to be the most advantageous to the City in the provision of law enforcement supplies; and

WHEREAS, Vendor has manifested the capability and willingness of providing the supplies pursuant to the IFB requirements, for a term of one (1) year, with two (2) options to renew at the option of the City Manager or authorized designee; and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interest to approve the selection of Vendor and to further authorize the City Manager to issue purchase orders, in an amount not to exceed Fifty Thousand Dollars (\$50,000.00) annually.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Selection of Contractor. The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of Lou's Distributors, Inc., for the

provision of Law Enforcement Uniforms, Equipment & Accessories, in accordance with the terms, conditions and specifications contained in Invitation for Bid #24-18-19, for an initial term of one (1) year, with two (2) options to renew at the option of the City Manager or designee.

Section 2. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders in an amount not to exceed Fifty Thousand Dollars (\$50,000.00) annually.

Section 3. Effective Date. This Resolution shall be effective upon adoption.
