

RESOLUTION NO. 2019-R-27

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING A MEMORANDUM OF UNDERSTANDING ESTABLISHING A PARTNERSHIP WITH THE CITY OF NORTH MIAMI PUBLIC LIBRARY, DIGITAL LIBRARY OF THE CARIBBEAN (DLOC), AND FIU LIBRARIES FOR THE YEAR OF 2019-2020; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the purpose and scope of the proposed Memorandum of Understanding is to establish a framework for cooperation and partnership between Digital Library of the Caribbean, (dLOC), FIU Libraries, and City of North Miami Public Library to facilitate the preservation and accessibility of Caribbean library research materials; and

**WHEREAS**, dLOC will provide contact information for dLOC staff members to resolve any issues related to the kiosk, publicize the kiosk location through social media networks, provide technical support for issues related to the kiosk, and retain ownership of the kiosk; and

**WHEREAS**, City of North Miami Public Library will provide contact information for City of North Miami Public Library staff members to resolve any issues related to the kiosk, publicize the kiosk's location throughout the City of North Miami Public Library marketing communications and social media networks, and take responsibility of reporting any damages to the kiosk; and

**WHEREAS**, collaborative efforts will be taken by the parties to meet semi-annually to coordinate changes about the kiosk and participate in ongoing problem solving and evaluation of the kiosk.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

**Section 1. Approval of Memorandum of Understanding.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the Memorandum of Understanding between the City of North Miami Public Library, Digital Library of the Caribbean, and Florida International University Libraries.

**Section 2. Authority of City Manager.** The City Manager is authorized to execute the Memorandum of Understanding attached as "Exhibit 1".

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
