

RESOLUTION NO. 2019-R-31

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE CITY MANAGER'S EMERGENCY PROCUREMENT AND ISSUANCE OF A PURCHASE ORDER TO T.V. DIVERSIFIED, LLC, IN THE AMOUNT NOT-TO-EXCEED ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000.00), FOR EMERGENCY MANHOLE REPAIRS; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, a large portion of the City of North Miami's ("City's") sanitary gravity system is located within a Miami-Dade County wellfield protection area which is governed by the Miami-Dade County Code and must comply with specific criteria set forth in the Code; and

**WHEREAS**, City staff identified a manhole at the intersection of N.W. 127<sup>th</sup> Street and N.W. 11<sup>th</sup> Avenue in need of immediate repairs in order to comply with Miami-Dade County's requirements and to avoid potential damage to property or injury to residents; and

**WHEREAS**, Section 7-144, City Code, allows the City Manager to make emergency procurements when there exists an immediate threat to public health, welfare, or safety or to prevent or minimize serious disruption of government services; and

**WHEREAS**, it was determined that the most appropriate course of action was to hire a vendor, on an emergency basis, to perform manhole repairs ("Services"), in the amount not-to-exceed One Hundred Fifty Dollars (\$150,000.00); and

**WHEREAS**, in an effort to expedite the repairs, City staff contacted three (3) vendors to obtain quotes for all labor, materials, services and equipment required for completion of the repairs; and

**WHEREAS**, upon review of the quotes, it was determined that T.V. Diversified, LLC ("Vendor") submitted the lowest responsive quote and the most advantageous in the procurement of Services; and


**WHEREAS**, for the benefit of the public health, safety and welfare of City residents and users of City facilities, City administration respectfully requests that the Mayor and City Council ratify the issuance of the purchase orders, pursuant to Section 7-144, City Code of Ordinances.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification.** The Mayor and City Council of the City of North Miami, Florida, hereby ratify the City Manager's issuance of Purchase Orders in the amount not-to-exceed One Hundred Fifty Thousand Dollars (\$150,000.00) to T.V. Diversified, LLC, to provide emergency manhole repairs, pursuant to Section 7-144, City Code of Ordinance.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
