

RESOLUTION NO. 2025-R-173

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING A CHANGE ORDER TO THE EXISTING AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND GREEN WISE GROUP, LLC, FOR ADDITIONAL TREE TRIMMING SERVICES, IN AN AMOUNT NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00), PURSUANT TO INVITATION FOR BIDS NO. 47-23-24; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on May 15, 2024, the City of North Miami (“City”) issued *Invitation for Bids No. 47-23-24 –Tree Trimming Services* (“IFB”), seeking bids from qualified and experienced contractors to provide the City with citywide tree trimming services (“Services”), in accordance with the terms, conditions and specifications contained in the IFB (“Services”); and

WHEREAS, in response to the IFB, the City received five (5) bids and Green Wise Group, LLC (“Contractor”), was determined to be the lowest responsive and responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, on September 10, 2024, the Mayor and City Council of the City of North Miami, Florida, adopted Resolution No. 2024-R-117 authorizing the City Manager to negotiate and execute an agreement between the City of North Miami and Green Wise Group, LLC, for tree trimming services to be provided in an amount not exceeding One Hundred Five Thousand Three Hundred Twelve Dollars (\$105,312.00) annually; and

WHEREAS, in evaluating the condition of the tree canopies throughout the City it was determined that there is a need for additional Services to ensure that the City’s tree canopies will be properly maintained; and

WHEREAS, City administration recommends the purchase of additional services, in an amount not to exceed Fifty Thousand Dollars (\$50,000.00) to provide additional maintenance to the City’s tree canopies; and

WHEREAS, City administration respectfully requests that the Mayor and City Council authorize the proposed change order to the existing agreement with the Contractor for the provision of additional tree trimming services.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue the proposed change order to the existing agreement between the City of North Miami and Green Wise Group, LLC, for additional tree trimming services, in an amount not to exceed Fifty Thousand Dollars (\$50,000.00).

Section 2. Effective Date. This Resolution shall be effective upon adoption.
