

**RESOLUTION NO. 2025-R-172**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE ACTING CITY MANAGER'S EMERGENCY PROCUREMENT AND ISSUANCE OF PURCHASE ORDERS TO ABSOLUTE CONSTRUCTION SERVICES, INC., IN THE AMOUNT OF ONE HUNDRED FORTY-TWO THOUSAND SIX HUNDRED NINETY DOLLARS (\$142,690.00), FOR THE REPLACEMENT OF A 72-INCH CORRUGATED METAL PIPE (CMP), LOCATED ALONG N.E. 15th AVENUE, PURSUANT TO SECTION 7-144 OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami ("City") Public Works department recently identified a damaged pipe which partially collapsed and prevented water from flowing properly resulting in a potential public health hazard and interruption of services to the City's residents; and

**WHEREAS**, it was determined that the emergency repairs would entail the replacement of a section of the 72-inch CMP pipe located along N.E. 15<sup>th</sup> Avenue; and

**WHEREAS**, Section 7-144 of the City Code, allows the City Manager to make emergency procurements when there exists an immediate threat to public health, welfare, or safety or to prevent or minimize serious disruption of government services; and

**WHEREAS**, in order to complete the repairs in an expeditious manner, City staff obtained a proposal from Absolute Construction Services, Inc., to perform the necessary emergency pipe replacement; and

**WHEREAS**, the cost for completion of the necessary emergency work is One Hundred Forty-Two Thousand Six Hundred Ninety Dollars (\$142,690.00); and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council ratify the Acting City Manager's issuance of the purchase order, pursuant to Section 7-144 of the City Code of Ordinances.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification.** The Mayor and City Council of the City of North Miami, Florida, hereby ratify the Acting City Manager's emergency procurement and issuance of


Purchase Orders in the amount of One Hundred Forty-Two Thousand Six Hundred Ninety Dollars (\$142,690.00), to Absolute Construction Services, Inc., for the replacement of a 72-inch CMP pipe located along N.E. 15<sup>th</sup> Avenue, pursuant to Section 7-144 of the City Code of Ordinances.

**Section 2.** **Effective Date.** This Resolution shall become effective immediately upon adoption.
