

**RESOLUTION NO. 2025-R-170**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO NXT GEN TECHNOLOGIES, INC., IN AN AGGREGATE AMOUNT NOT TO EXCEED TWO HUNDRED NINETY-NINE THOUSAND FOUR HUNDRED FIFTEEN DOLLARS (\$299,415.00), FOR A THREE (3) YEAR SUBSCRIPTION OF VARONIS HYBRID + MDDR & COPILOT SaaS, A CLOUD-BASED CYBER SECURITY SYSTEM, PURSUANT TO SECTION 7-121(21) OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, to support ongoing security efforts, the City of North Miami (“City”) information technology department recommends the enrollment into a three (3) year subscription to Varonis Hybrid + MDDR & Copilot SaaS, a cloud based cyber security platform needed to enhance the security of access to the City’s digital data and operational systems; and

**WHEREAS**, additionally, the recommended program will ensure the City remains in compliance with applicable governmental regulations and industry standards; and

**WHEREAS**, the IT department recommends the issuance of purchase orders to NXT GEN Technologies, Inc., in an amount not to exceed Two Hundred Ninety-Nine Thousand Four Hundred Fifteen Dollars (\$299,415.00), to facilitate the City’s subscription to the recommended software platform; and

**WHEREAS**, in accordance with Section 7-121 of the City Code, the purchase of telecommunications, internet, and cybersecurity services are exempt from the provisions of the Procurement Code; and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council authorize the issuance of the purchase orders, pursuant to Section 7-121, City Code of Ordinances.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue Purchase Orders in an aggregate amount not-to-exceed exceed Two Hundred Ninety-Nine Thousand Four Hundred Fifteen Dollars (\$299,415.00), to NXT GEN Technologies, Inc., for a three (3) year subscription to Varonis

Hybrid + MDDR & Copilot SaaS, a cloud based cyber security system, pursuant to Section 7-121, City Code of Ordinances.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
