

RESOLUTION NO. 2025-R-180

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EVALUATION COMMITTEE'S SELECTION OF WSB, LLC, AS THE HIGHEST RANKED FIRM TO PROVIDE CONSTRUCTION ENGINEERING AND INSPECTION (CEI) SERVICES FOR THE PEDESTRIAN BRIDGE REPLACEMENT OVER C-8 CANAL PROJECT; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONSULTANT, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED THREE HUNDRED TWENTY-FOUR THOUSAND FIVE HUNDRED SEVENTEEN DOLLARS (\$324,517.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN REQUEST FOR QUALIFICATIONS NO. 60-23-24; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on July 1, 2024, the City of North Miami ("City") issued *Request for Qualifications No. 60-23-24 – Construction Engineering and Inspection (CEI) Services* ("RFQ"), for the selection of a firm to provide Construction Engineering and Inspection (CEI) Services for the Pedestrian Bridge Replacement Over C-8 Canal project in accordance with the terms outlined in the Local Agency Program ("LAP") Agreement that the City entered into with the Florida Department of Transportation ("FDOT") (collectively referred hereto as "Services"); and

WHEREAS, in response to the RFQ, the City received and opened four (4) proposals; and

WHEREAS, WSB, LLC, ("Consultant") was evaluated to be the highest ranked firm, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Mayor and City Council, find the execution of an agreement with Consultant for provision of Services is in the City's best interest.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Selection Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the Evaluation Committee's selection of WSB, LLC, as the

highest ranked firm to provide Construction Engineering and Inspection (CEI) Services for the Pedestrian Bridge Replacement Over C-8 Canal project.

Section 2. **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate an agreement with WSB, LLC, in accordance with the terms, conditions and specifications contained in *Request for Qualifications No. 60-23-24 – Construction Engineering and Inspection (CEI) Services for the Pedestrian Bridge Replacement Over C-8 Canal Project.*


Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
