

RESOLUTION NO. 2025-R-179

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER'S ISSUANCE OF PURCHASE ORDERS TO METRO EXPRESS, INC., FOR ADDITIONAL SERVICES RELATED TO THE INSTALLATION OF A CONCRETE WALKING PATH WITHIN THE ARCH CREEK EAST PASSIVE PARK, LOCATED AT 2699 N.E. 135TH STREET, IN AN AGGREGATE AMOUNT NOT TO EXCEED SIXTY-TWO THOUSAND DOLLARS (\$62,000.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on November 26, 2024, the Mayor and City Council of the City of North Miami ("City") adopted Resolution No. 2024-R-187 authorizing the issuance of purchase orders to various vendors for construction and maintenance of concrete curbing, sidewalks, as well as frequent roadway milling and resurfacing; and

WHEREAS, the services were procured in accordance with section 7-167 of the Code of Ordinances, by utilizing the City of Dania Beach Invitation to Bid No. 24-021-0-2024 - "Concrete Curbing/Sidewalk Construction, Milling and Resurfacing of Asphalt Concrete, Striping of City Streets and Parking Lots, and Lane Delineators"; and

WHEREAS, the City engaged Metro Express, Inc., from the approved vendor list, to provide additional services related to the construction of a concrete walking path within the Arch Creek East Passive Park; and

WHEREAS, in 2021, a walking path was installed within the eastern-most median on N.E. 135th Street; and

WHEREAS, the City is desirous of extending the walking path as this feature has been very popular among the neighborhood residents and there have been numerous requests to continue the walking path through the medians that make up the linear park; and


WHEREAS, City administration respectfully requests that the Mayor and City Council authorize the issuance of purchase orders for completion of additional services related to the extension of the Arch Creek East Passive Park walking path.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Metro Express, Inc., in an aggregate amount to exceed Sixty-Two Thousand Dollars (\$62,000.00) for additional services related to the installation of a concrete walking path within the Arch Creek East Passive Park, located at 2699 N.E. 135th Street.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
