

RESOLUTION NO. 2025-R-178

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF
THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING
THE ISSUANCE OF PAYMENTS TO EVENTOLOGY MIAMI,
LLC FOR THE PROVISION OF CONSULTING SERVICES
TO SUPPORT VARIOUS CITY EVENTS, COMMUNITY
INITIATIVES, AND SPONSORSHIPS; PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, on November 4, 2024, the City of North Miami (“City”) entered into an agreement with Eventology Miami, LLC (“Eventology”) for consulting services needed to support various City events, community initiatives, and sponsorships; and

WHEREAS, the Agreement was for a six (6) month term commencing October 1, 2024, through March 30, 2025, at a rate of Five Thousand Dollars (\$5,000.00) per month for a total contract amount of Thirty Thousand Dollars (\$30,000.00), which has already been paid; and

WHEREAS, given the level of services provided by Eventology, it was necessary for City staff to extend the use of their services for an additional four (4) month period to ensure the success of various community events including multiple food drives, as well as Mother’s Day and Father’s Day events; and

WHEREAS, the additional services provided during the four (4) month period at the contract rate of Five Thousand Dollars (\$5,000.00) per month represents a total amount of Twenty Thousand Dollars (\$20,000.00) due to the vendor for services rendered; and

WHEREAS, as the aggregate amount due for services rendered under the Agreement will total Fifty Thousand Dollars (\$50,000.00), City Administration respectfully requests authorization from the Mayor and City Council for payment of the additional services; and

WHEREAS, the Mayor and City Council find that the additional services were necessary and hereby authorize payment for the services rendered.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authorization. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the issuance of payments in an aggregate amount totaling Fifty Thousand


Dollars (\$50,000.00) to Eventology Miami, LLC for the provision of consulting services to support various City events, community initiatives, and sponsorships.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
