

RESOLUTION NO. 2019-R-52

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO PB LOADER CORPORATION, UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE, ON A CONTRACT AWARDED THROUGH SOURCEWELL, AT A COST NOT TO EXCEED ONE HUNDRED NINETY TWO THOUSAND TWO HUNDRED SEVENTY FIVE DOLLARS (\$192,275.00) FOR THE PURCHASE OF A 2017 FREIGHTLINER M2 106 CHASSIS FRONT END LOADER; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) desires the purchase of a 2017 Freightliner M2 106 Chassis Front End Loader; and

WHEREAS, Sourcewell is a governmental purchasing cooperative with over fifty thousand (50,000) member agencies which establishes and provides nationally leveraged and competitively solicited purchasing contracts under the guidance of the Uniform Municipal Contracting Law; and

WHEREAS, on April 6, 2017, Sourcewell issued RFP No. 052417 “Roadway Maintenance Equipment with Related Accessories, Attachments, Materials, and Supplies” seeking responsive and responsible vendors to establish national contracts to provide quality product/equipment and services for its fleet needs; and

WHEREAS, PB Loader Corporation (“Vendor”), was competitively selected by Sourcewell and was subsequently awarded Contract No. 052417-PBL through October 2, 2021; and

WHEREAS, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

WHEREAS, in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to execute purchase orders for the provision of Services, based on a competitive price to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue a purchase order to PB Loader Corporation, utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code, on a contract awarded through Sourcewell, at a cost not to exceed One Hundred Ninety Two Thousand Two Hundred Seventy-Five Dollars (\$192,275.00), for the purchase of a 2017 Freightliner M2 106 Chassis Front End Loader.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
