## **RESOLUTION NO. 2019-R-54**

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, CANVASSING THE RETURNS AND CERTIFYING THE RESULTS OF AN ELECTION FOR COUNCILPERSON FOR DISTRICT NO. 1 IN THE CITY OF NORTH MIAMI, HELD ON MAY 14, 2019; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council of the City of North Miami, pursuant to Resolution 2019-R-7, called for a regular election which was held on May 14, 2019, in accordance with the Charter of the City of North Miami; and

WHEREAS, pursuant to law, the results of that election are to be canvassed and certified by the City Council.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Canvassing Returns. That the Mayor and City Council of the City of North Miami, Florida, have publicly canvassed the returns of the election of May 14, 2019 and have found that 1,403 total ballots were cast at the election for Councilperson for District No. 1.

Section 2. Election Results. That the Mayor and City Council of the City of North Miami, Florida, have found that 1,403 valid votes were cast for the office of Councilperson for District No. I as follows:

924 votes for SCOTT GALVIN

479 votes for VANESSA PIERRE

Section 3. Canvassing Board Findings. That the Mayor and City Council of the City of North Miami, Florida, sitting as the Canvassing Board have found that SCOTT GALVIN has received the highest number of votes, for Councilperson for District No. 1 and that SCOTT GALVIN is declared elected and shall hold office as Councilperson for District No. 1 until the second Tuesday following the general election in May, 2023.
