

RESOLUTION NO. 2019-R-60

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE NEGOTIATION AND EXECUTION OF AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND FEEDING SOUTH FLORIDA, INC. IN AN AMOUNT NOT-TO-EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00) TO ESTABLISH A FEEDING SOUTH FLORIDA FOOD PANTRY IN THE CITY OF NORTH MIAMI; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, Feeding South Florida, Inc. (“FSF”) is a non-profit, community organization whose mission is to end hunger in South Florida by providing immediate access to nutritious food, by leading hunger and poverty advocacy efforts, and by transforming lives through innovative programming and education; and

**WHEREAS**, to accomplish this mission, FSF solicits community partners to assist in the administration of the program; and

**WHEREAS**, FSF wishes to broaden its program and offer services to City of North Miami (“City”) residents, including a food pantry, registered dietician nutrition classes, and assistance with SNAP, TCA, Medicaid and Florida Kidcare Applications; and

**WHEREAS**, the City recognizes the need to place these resources within our community and has proposed Sunkist Grove Community Center as the service location; and

**WHEREAS**, the City of North Miami supports this initiative and commits to a one (1) year sponsorship of the endeavor; and

**WHEREAS**, the Mayor and City Council believe that it is in the best interest of the City and its residents to enter into an agreement with FSF, for the sponsorship of a FSF Food Pantry.


**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Sponsorship of Feeding South Florida, Inc.** The Mayor and City Council hereby authorize the sponsorship of a Food Pantry at in an amount not-to-exceed Fifty Thousand Dollars (\$50,000.000).

**Section 2. Authority of City Manager and City Attorney.** The City Council hereby authorizes the City Manager and City Attorney to negotiate and execute a Sponsorship Agreement with Feeding South Florida, Inc.

**Section 3. Effective Date.** This Resolution will be effective immediately upon adoption.
