**SUMMARY AND NOTICE FOR PUBLIC COMMENT ON
PY2021-2024 REPROGRAMMING OF FUNDS**

Annually, the City of North Miami (City) receives an allocation of federal Community Development Block Grant (CDBG) funding from the U.S. Department of Housing and Urban Development (HUD). Notice is hereby given that the City, through its Housing and Social Services (HSS) Department, proposes the reprogramming of CDBG funds to be reallocated from various activities and various grant years as outlined in the table below.

In accordance with 24 CFR Part 91 and the Citizen Participation Plan, the City of North Miami invites public review and comment on proposed program amendments to reprogram CDBG funds. While this amendment does not meet the definition of a substantial amendment since it does not change an activity's budget by more than 10%, cancel an approved activity, or initiate a new activity, the City is voluntarily providing notice and a comment period to promote transparency and keep residents informed. After receiving public comments, the reprogramming will be submitted to the City Manager for approval, and changes will be made to HUD's Integrated Disbursement and Information System (IDIS) to reflect the reprogramming.

PUBLIC COMMENT PERIOD AND PROCESS:

This request for reprogramming is available for a 15-day public review and comment period from **October 16, 2025, to October 31, 2025**. Citizens wishing to submit written comments during the public review and comment period may mail them, postmarked no later than **October 31, 2025**, to the following address:
