

RESOLUTION NO. 2019-R-67

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA APPROVING THE EXECUTION OF A MULTI-AGENCY OPERATIONAL ASSISTANCE MUTUAL AID AGREEMENT TO PROVIDE FOR THE NORTH MIAMI POLICE DEPARTMENT'S PARTICIPATION IN THE MIAMI-DADE COUNTY ISLAND CHIEFS REGIONAL MOBILE FORCE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the entering of a an operational assistance agreement between municipalities for law enforcement cooperation and assistance is authorized by Chapter 23, Florida Statutes, Florida Mutual Aid Act; and

WHEREAS, several law enforcement agencies have joined together in a multi-jurisdictional unit known as the Miami-Dade County Island Chief's Regional Mobile Field Force Unit; and

WHEREAS, the North Miami Police Department has determined that it can make a more efficient use of its powers and resources by providing a higher quality of law enforcement service to the public by joining the multi-jurisdictional unit; and

WHEREAS, the Mayor and City Council believe that the Multi-Agency Operational Assistance Mutual Aid Agreement will benefit the residents of the City of North Miami and should be entered into.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Approval of Agreement. The City Council hereby approves the Miami-Dade County Island Chief's Regional Mobile Field Force Multi-Agency Operational Assistance Mutual Aid Agreement attached as "Exhibit 1."

Section 2. Authority of City Manager and Police Chief. The City Manager and the Chief of Police are authorized to execute the Multi-Agency Operational Assistance Mutual Aid Agreement, attached as "Exhibit 1".

Section 3. Effective Date. This Resolution will be effective upon adoption.
