

RESOLUTION NO. 2019-R-70

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO MITY-LITE, INC., IN THE AGGREGATE AMOUNT NOT TO EXCEED THIRTY THOUSAND FOUR HUNDRED NINETY EIGHT DOLLARS (\$30,498), FOR THE PURCHASE OF TABLES AND CHAIRS FOR THE CITY'S SUMMER FOOD SERVICES PROGRAM, PIGGYBACKING MIAMI-DADE COUNTY RTQ NO. 00439; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") wishes to purchase tables and chairs for the City's Summer Food Services Program administered by the Parks and Recreation Department; and

WHEREAS, Miami-Dade County advertised *Request to Qualify ("RTQ") No. 00439 – Furniture Office & Non-Office* ("Solicitation"), seeking proposals from experienced and qualified vendors for the purchase and installation of furniture, including replacement parts, upholstery and associated products; and

WHEREAS, as a result of the Solicitation, Mity-Lite, Inc. ("Vendor") was evaluated and selected to be included in the approved pool of vendors in accordance with Miami-Dade County Resolution No. R-95-18; and

WHEREAS, in accordance with Section 7-167 of the City Code, the City administration may purchase supplies or services from current contracts of other governmental agencies ("Piggyback"), with City Council approval on any such purchase which exceeds Twenty-Five Thousand Dollars (\$25,000.00); and

WHEREAS, the City administration desires to Piggyback the existing Agreement between Miami-Dade County and Vendor, to obtain competitive pricing; and

WHEREAS, City administration respectfully requests approval to piggyback Vendor's contract with Miami-Dade County for issuance of Purchase Orders, in an amount not to exceed Thirty Thousand Five Hundred Ninety Eight Dollars (\$30,498) to provide the City with tables and chairs; and

WHEREAS, the Mayor and City Council find that the purchase of tables and chairs for the City's summer food services program, is in the best interest of the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders, to Mity-Lite, Inc., in an aggregate amount not to exceed Thirty Thousand Five Hundred Ninety Eight Dollars (\$30,498) for the purchase of tables and chairs for the City's summer food services program, piggybacking Miami-Dade County, *Request to Qualify No. 00439.*

Section 2. Effective Date. This Resolution shall be effective upon adoption.
