

**RESOLUTION NO. 2025-R-201**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND 300 ENGINEERING GROUP, LLC, FOR ADDITIONAL PROFESSIONAL ENGINEERING CONSULTING SERVICES NEEDED FOR THE COMPLETION OF THE LEAD AND COPPER RULE COMPLIANCE ASSISTANCE PROJECT, AT A COST NOT TO EXCEED SEVENTY-SIX THOUSAND DOLLARS (\$76,000.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on February 13, 2024, the Mayor and City Council of the City of North Miami (“City”) adopted Resolution No. 2024-R-19 authorizing the City Manager to enter into an Agreement with 300 Engineering Group, LLC (“Consultant”), to provide the City with professional engineering services needed for the completion of the Lead and Copper Rule (“LCR”) Compliance Assistance Project; and

**WHEREAS**, the City desires to amend the Agreement to include additional professional engineering services needed to complete the LCR project to ensure the City’s compliance with the requirements promulgated by the Florida Department of Environmental Protection (“Services”); and

**WHEREAS**, the additional services will include: project management, public interface assistance, quarterly lead service line inventory updates, compliance reporting, and GIS training and support; and

**WHEREAS**, the required additional Services will cost the City an amount not to exceed Seventy-Six Thousand Dollars (\$76,000.00), with an estimated project completion date of fifteen (15) months from the City’s issuance of notice to proceed; and

**WHEREAS**, the City Administration respectfully requests that the Mayor and City Council approve the proposed amendment to the Agreement, in order to complete the LCR Project.


**WHEREAS**, the Mayor and City Council have determined that it is in the City's best interests to authorize the City Manager and City Attorney to negotiate and execute an amendment to the agreement for the provision of the required additional engineering services.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, THAT:**


**Section 1.**     **Authority of City Manager and City Attorney.**     The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an amendment to the Agreement between the City of North Miami and 300 Engineering Group, LLC, to include additional professional engineering services needed for the completion of the Lead and Copper Rule Compliance Assistance Project, at a cost not to exceed Seventy-Six Thousand Dollars (\$76,000.00).

**Section 2.**     **Effective Date.**     This Resolution shall become effective immediately upon adoption.
