

RESOLUTION NO. 2025-R-200

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND 300 ENGINEERING GROUP, LLC, FOR ADDITIONAL ENGINEERING SERVICES REQUIRED FOR THE COMPLETION OF THE SANITARY SEWER EVALUATION SURVEY (“SSES”) PROJECT – THIRD CYCLE PHASE 2 SURVEY AND REPORT, AT A COST NOT TO EXCEED FOUR HUNDRED FIFTY-EIGHT THOUSAND AND TWO DOLLARS (\$458,002.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on October 25, 2022, the Mayor and City Council of the City of North Miami (“City”) adopted Resolution No. 2022-R-179 authorizing the City Manager to enter into an Agreement with 300 Engineering Group, LLC (“Consultant”), to provide the City with professional engineering services needed for the completion of the City’s Sanitary Sewer Evaluation Survey (“SSES”) and

WHEREAS, the City desires to amend the Agreement to include additional engineering services needed to complete the SSES project to ensure the City’s compliance with the requirements promulgated by the Florida Department of Environmental Protection and Miami-Dade County Department of Regulatory and Economic Resources (“Services”); and

WHEREAS, the additional services will include: project management services, data collection and analysis, SSES – Phase 2, updated Corrected Action Plan tables, SSES Third Cycle reporting; and

WHEREAS, the required additional services will cost the City an amount not to exceed Four Hundred Fifty-Eight Thousand and Two Dollars (\$458,002.00); and

WHEREAS, the City Administration respectfully requests that the Mayor and City Council approve the proposed amendment to the Agreement with the Consultant, in order to complete the SSES Project.

WHEREAS, the Mayor and City Council have determined that it is in the City's best interests to authorize the City Manager and City Attorney to negotiate and execute an amendment to the agreement for the provision of the required additional engineering services.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, THAT:

Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an amendment to the Agreement between the City of North Miami and 300 Engineering Group, LLC, to include additional engineering services needed for the completion of the Sanitary Sewer Evaluation Survey Project – Third Cycle Phase 2 Survey and Report, at a cost not to exceed Four Hundred Fifty-Eight Thousand and Two Dollars (\$458,002.00).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
