**WHEREAS**, the City of North Miami Police Department (“NMPD”) and the City of Panama City Beach Police Department (“PCBPD”) are both criminal justice agencies as recognized by the Federal Bureau of Investigation (“FBI”) and the Florida Department of Law Enforcement (“FDLE”); and

**WHEREAS**, both agencies are parties to User Agreements with FDLE and are required to comply with the FBI Criminal Justice Information Services Security Policy (“CJISSECPOL”); and

**WHEREAS**, both agencies have contracted with FLOCK Safety, a private company, for services supporting the administration of criminal justice systems containing Criminal Justice Information (“CJI”); and

**WHEREAS**, the CJISSECPOL requires criminal justice agencies to execute vendor agreements and ensure appropriate background screening of vendor personnel with access to CJI; and

**WHEREAS**, this Agreement is required to maintain compliance with FBI and FDLE security standards and to ensure proper collaboration and information sharing between agencies; and

**WHEREAS**, the proposed Interagency Lead Contract Agency Agreement designates the City of Panama City Beach Police Department as the Lead Contract Agency to fingerprint, screen, and maintain records of FLOCK Safety employees authorized to access CJI, and to share such information with the City of North Miami Police Department, as the Contract Agency; and

**WHEREAS**, the proposed Interagency Lead Contract Agency Agreement designates the City of Panama City Beach Police Department as the Lead Contract Agency to fingerprint, screen, and maintain records of FLOCK Safety employees authorized to access CJI, and to share such information with the City of North Miami Police Department, as the Contract Agency; and

**WHEREAS**, the Mayor and City Council find that it is in the best interests of the City and its residents to authorize the execution of this Agreement between NMPD and PCBPD for these purposes.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1.**      **Authority of the City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to execute the Interagency Lead Contract Agency Agreement with the City of Panama City Beach Police Department, in substantially the form attached hereto as Exhibit "A."

**Section 2.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
