

RESOLUTION NO. 2019-R-84

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND CRAVEN THOMPSON & ASSOCIATES, INC., TO INCLUDE CONSTRUCTION ADMINISTRATION SERVICES, AT A COST NOT TO EXCEED ONE HUNDRED FIFTY-NINE THOUSAND THREE HUNDRED EIGHTY-FIVE DOLLARS (\$159,385.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on November 19, 2018, the City of North Miami (“City”) entered into an Professional Services Agreement with Craven Thompson & Associates, Inc. (“Consultant”), to provide the City with construction administration services for two water main projects, in accordance with the technical specifications, terms, and conditions contained in *Request for Qualifications #12-14-15, Continuing Architectural & Engineering Services* (“RFQ”);

WHEREAS, the City desires to amend the Agreement to include additional construction administration services during the construction phase due to the complexity of the project and Consultant’s knowledge of the project (“Additional Services”); and

WHEREAS, Additional Services will include: public awareness assistance, onsite civil engineering construction observation and civil project final certifications; and

WHEREAS, the Additional Services can be obtained by amending the Agreement at a cost not to exceed One Hundred Fifty-Nine Thousand Three Hundred Eighty-Five Dollars (\$159,385.00); and

WHEREAS, the City Administration respectfully requests that the Mayor and City Council authorize an amendment to the Agreement to attain Additional Services for the aforementioned reasons, benefiting the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney

to negotiate and execute an amendment to the agreement between the City of North Miami and Craven Thompson & Associates, Inc., to include additional construction administration services, at a cost not to exceed One Hundred Fifty-Nine Thousand Three Hundred Eighty-Five Dollars (\$159,385.00) and an agreed upon duration of approximately seven (7) months from the City's issuance of a Notice-to Proceed.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
