

**RESOLUTION NO. 2025-R-225**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE ISSUANCE OF PURCHASE ORDERS TO VARIOUS VENDORS, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED THIRTY THOUSAND DOLLARS (\$130,000.00), FOR THE PURCHASE OF SUPPLIES AND CONSUMABLE GOODS FOR COMMUNITY INITIATIVES AND ACTIVITIES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) routinely hosts community initiatives and activities throughout the year for the benefit of City residents; and

**WHEREAS**, City staff is requesting the issuance of purchase orders to purchase supplies and consumable goods in support of these activities, in an amount not to exceed One Hundred Thirty Thousand Dollars (\$130,000.00); and

**WHEREAS**, City Administration supports the request as these items have been included in the annual budget; and


**WHEREAS**, the Mayor and City Council find that the purchase of supplies and consumable goods for community initiatives and activities is in the best interest of the City and its residents, and authorize the City Manager to issue purchase orders in support of this objective.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1. Authorization to City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to various vendors, in an amount not-to-exceed One Hundred Thirty Thousand Dollars (\$130,000.00) for the purchase of supplies and consumable goods for community initiatives and activities.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
