

RESOLUTION NO. 2019-R-91

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A CHANGE ORDER TO FLORIDA ENGINEERING & DEVELOPMENT CORPORATION, IN THE AMOUNT OF THIRTY-THREE THOUSAND TWO HUNDRED TWENTY-FIVE DOLLARS AND NINETY-NINE CENTS (\$33,225.99), TO COMPLETE THE N.E. 143RD STREET WATER MAIN IMPROVEMENTS PROJECT; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on June 26, 2018, the City of North Miami (“City”) adopted Resolution No. 2018-R-82 approving the selection of Florida Engineering & Development Corporation (“Contractor”) for the completion of the N.E 143rd Street Water Main Improvements Project (the “Services”) in accordance with Invitation for Bid No. 23-17-18; and

WHEREAS, as a result of unforeseen conditions, an adjustment to the original scope of work is required to successfully complete the project, including additional water main connections at a cost of thirty-three thousand two hundred twenty-five dollars and ninety-nine cents (\$33,225.99); and

WHEREAS, City administration respectfully requests approval for the additional expenditure of funds to ensure the restoration of the water mains to the proper level of service and for completion of the project; and

WHEREAS, the Mayor and City Council of the City of North Miami, Florida, find that authorizing the City Manager to issue a change order for the additional Services to be provided by Contractor is in the best interests of the City.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. City Manager Authorization. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue a change order to Florida Engineering & Development Corporation in the amount of thirty-three thousand two hundred twenty-five dollars and ninety-nine cents (\$33,225.99) to encompass the additional costs required to complete the N.E.143rd Street Water Main Improvements Project.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
