

RESOLUTION NO. 2019-R-92

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SELECTION OF V ENGINEERING & CONSULTING CORP., AS THE LOWEST, RESPONSIVE AND RESPONSIBLE CONTRACTOR TO PERFORM THE 125 STREET BEAUTIFICATION PROJECT, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 41-18-19, FURTHER RATIFYING THE EXECUTION OF AN AGREEMENT WITH V ENGINEERING & CONSULTING CORP., FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY THOUSAND FIVE HUNDRED DOLLARS (\$120,500.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on March 20, 2019, the City of North Miami (“City”) advertised *Invitation for Bid No. 41-18-19 – SR 922 – NE 125th Street Beautification Project* (“IFB”), soliciting qualifications from experienced and qualified contractors to perform a beautification project along N.E. 125th Street between Griffing Blvd. to North Bayshore Drive; and

WHEREAS, pursuant to the IFB, the selected contractor is required to provide all necessary labor, equipment, materials and expertise required for the implementation and completion of the beautification project including, but not limited to: installation of landscaping improvements, removal of several existing trees, concrete and pavers, installation of new trees in concrete and pavers, maintenance of traffic and installation of root barriers (“Services”); and

WHEREAS, V Engineering & Consulting Corp. (“Contractor”), timely submitted its bid and was evaluated by City administration as the lowest responsive-responsible bidder whose bid, qualifications and references demonstrated to be the most advantageous to the City in the procurement of the Project; and

WHEREAS, the Mayor and City Council have determined that it is in the City’s best interests to approve the selection of Contractor and ratify the execution of an agreement for the provision of Services to perform the beautification project.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification of Selection. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the City administration's ranking and selection of V Engineering & Consulting Corp., Inc. as the lowest, responsive and responsible contractor to perform the 125th Street Beautification Project, in accordance with the terms, conditions and specifications contained in *IFB No. 41-18-19 – SR 922 – 125th Street Beautification Project*.

Section 2. Ratification of Agreement. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the execution of an agreement for the provision of Services with V Engineering & Consulting Corp., at a cost not to exceed One Hundred Twenty Thousand Five Hundred Dollars (\$120,500.00).

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
