

RESOLUTION NO. 2019-R-94

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S SELECTION OF STAGELINE MOBILE STAGE, INC., TO PROVIDE A NEW MOBILE STAGE UNIT; FURTHER AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONTRACTOR IN AN AMOUNT NOT TO EXCEED ONE HUNDRED NINETY-FOUR THOUSAND AND TWENTY-TWO DOLLARS (\$194,022.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BIDS NO. 10-18-19; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, on August 9, 2019, the City of North Miami ("City") issued *Invitation for Bids No. 10-18-19 – Mobile Stage Unit* ("IFB"), requesting bids from qualified and experienced manufacturers to provide a new mobile stage unit to be used for various City events, in accordance with the terms, conditions and specifications contained in the IFB; and

**WHEREAS**, in response to the IFB, the City received one (1) bid and Stageline Mobile Stage, Inc. ("Contractor"), was determined to be the lowest responsive and responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of the desired equipment; and

**WHEREAS**, the selected mobile stage design (Stageline SL100) combines technologies and patented telescopic lifting mechanisms making it the most advanced mobile staging system of its size available; and

**WHEREAS**, the Contractor has manifested the capability and willingness of providing the mobile stage unit to the City for a total cost of One Hundred Ninety-Four Thousand Twenty-Two Dollars (\$194,022.00); and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor and further authorize an agreement for the provision of the new mobile stage unit.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's selection of Stageline Mobile Stage, Inc., as the lowest responsive and responsible contractor to provide a new mobile stage unit.

**Section 2. Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to negotiate and execute an agreement to purchase a new mobile stage unit in an amount not to exceed of One Hundred Ninety Four Thousand Twenty-Two Dollars (\$194,022.00), in accordance with the terms, conditions and specifications contained in *Invitation for Bids No. 10-18-19 – Mobile Stage Unit*.

**Section 3. Effective Date.** This Resolution shall be effective immediately upon adoption.
