

RESOLUTION NO. 2018-R-3

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, ADOPTING AMENDED NORTH MIAMI ADULT EDUCATION CENTER GRANT PROGRAM MONITORING GUIDELINES AND AUTHORIZING THE CITY MANAGER TO EXECUTE A PROGRAM GRANT AGREEMENT, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE CITY OF NORTH MIAMI AND THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, TO FUND AND IMPLEMENT THE ADULT EDUCATION TUITION PROGRAM FOR ECONOMICALLY CHALLENGED CITY RESIDENTS ATTENDING NORTH MIAMI SENIOR HIGH SCHOOL DURING THE 2017-2018 SCHOOL YEAR, AT A COST NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) last approved the adoption of the North Miami Adult Education Center Tuition Grant Program monitoring guidelines in January 2013; and

WHEREAS, since that time, the program has undergone efficient improvements and updates requiring written codification of new procedures and guidelines; and

WHEREAS the City desires to fund and implement the Adult Education Tuition Program for City residents, enrolling at the North Miami Senior High School (“Educational Program”), commencing with the winter trimester of the 2017-2018 school year, at a cost to the City not to exceed Fifty Thousand Dollars (\$50,000.00); and

WHEREAS, the Mayor and City Council recognize that skills training and educational attainment are necessary components of a strong workforce and help promote the economic prosperity of its residents; and

WHEREAS, the Mayor and City Council acknowledge that sponsoring the Adult Education Grant Program is in the best interest of the City, and hereby find that the proposed Program Grant Agreement between the City and the School Board of Miami-Dade County, Florida, will enhance the public’s health, safety and welfare.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Adoption of Amended Guidelines. The Mayor and City Council of the City of North Miami, Florida, hereby adopt the amended grant program monitoring guidelines for monitoring and implementation of the North Miami Adult Education tuition reimbursement program and to update and streamline the grant procedures and protocols for oversight and monitoring in the form attached hereto as “Exhibit A”.


Section 2. Authorization of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to execute a Program Grant Agreement, between the City of North Miami and the School Board of Miami-Dade County, Florida, to fund and implement the Adult Education Tuition Program for economically challenged City residents attending North Miami Senior High School during the 2017-2018 school year, at a cost not to exceed Fifty Thousand Dollars (\$50,000.00), in the form attached hereto as “Exhibit B”.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
