

RESOLUTION NO. 2018-R-10

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE A NON-EXCLUSIVE LICENSE AGREEMENT, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE CITY OF NORTH MIAMI AND NEUTRON HOLDINGS, INC., FOR THE LIMEBIKE BICYCLE SHARING PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, Neutron Holdings, Inc., is a foreign profit corporation and qualified provider of bike share and related mobility products and services; and

WHEREAS, the City of North Miami desires to enter into a non-exclusive license agreement with Neutron Holdings, Inc. for the Limebike Bicycle Sharing Program; and

WHEREAS, the Limebike Bicycle Sharing Program will assist the City in achieving its goal to provide safe and affordable multi-modal transportation options to all residents, reduce traffic congestion, and maximize carbon-free mobility.

WHEREAS, it is respectfully requested that the Mayor and City Council authorize the City Manager and City Attorney to negotiate and execute a non-exclusive license agreement with Neutron Holdings, Inc.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Authority to execute agreement.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute a non-exclusive agreement, in substantially the attached form, between the City of North Miami and Neutron Holdings, Inc. for the Limebike Bicycle Sharing Program.

Section 2. **Effective Date.** This Resolution shall be effective upon adoption.
