

RESOLUTION NO. 2025-R-222

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO JET-VAC EQUIPMENT COMPANY, LLC, FOR THE PURCHASE OF A FREIGHTLINER PATCH TRUCK, AT AN APPROXIMATE AGGREGATE COST NOT TO EXCEED TWO HUNDRED FIFTY-TWO THOUSAND DOLLARS (\$252,000), UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE, ON A CONTRACT AWARDED THROUGH THE SOURCEWELL NATIONAL PURCHASING COOPERATIVE PROGRAM, UNDER CONTRACT NUMBER 050625-FRM; DECLARING THE EXISTING VEHICLE AS SURPLUS; AND PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) Public Works Department’s existing patch truck was purchased in 2009, has exceeded its expected useful life, and has been in and out of the repair shop several times over the last twelve (12) months for problems with the asphalt bin auger, with repairs proving to be unsuccessful; and

**WHEREAS**, in accordance with section 7-145 of the North Miami Code of Ordinances, the Procurement Director recommends that these vehicles be declared as surplus and disposed of in a manner most advantageous to the City; and

**WHEREAS**, City staff recommends that the existing patch truck be declared surplus and be replaced with a 2025 Freightliner that serves as the Vendor’s demonstration truck and has low highway mileage and less than an hour of usage on the hopper; and

**WHEREAS**, Sourcewell is a national purchasing cooperative which offers opportunities for member agencies to procure quality products/equipment and services as needed; and

**WHEREAS**, Sourcewell issued *Request For Proposals No. 050625 Roadway Maintenance Equipment*, proposers may include equipment, accessories, and services directly related to the Roadway Maintenance Equipment solutions; and

**WHEREAS**, as a result of these competitive solicitations, Falcon Road Maintenance Equipment, LLC dba Falcon Equipment Holdings, LLC was selected as part of a pool of vendors that manufactures the necessary equipment; and

**WHEREAS**, Jet-Vac Equipment Company, LLC (“Vendor”) is the authorized distributor for Falcon Equipment in the State of Florida; and

**WHEREAS**, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

**WHEREAS**, in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to issue purchase orders to Vendor for the provision of a Freightliner M2 Falcon 4-ton patch truck in an amount not to exceed Two Hundred Fifty-Two Thousand Dollars (\$252,000.00), based on Sourcewell Contract No. 050625-FRM; and

**WHEREAS**, the Mayor and City Council find the purchase of the patch truck at a substantial savings, in accordance with the Solicitation, to be in the best interest of the City.


**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**     **Declaration of Surplus.** The Mayor and City Council of the City of North Miami, Florida, hereby declare the following vehicle as surplus in accordance with Section 7-145 of the Code of Ordinances: One (1) Ford F-750 asphalt patch truck.


**Section 2.**     **Authority of the City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Jet-Vac Equipment Company, LLC, at an aggregate cost not to exceed Two Hundred Fifty-Two Thousand Dollars (\$252,000.00), utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code, for the purchase of a Freightliner Patch Truck, based on cooperative purchasing Contract No. 05062-FRM, issued through the Sourcewell national purchasing cooperative program.

**Section 3.**     **Effective Date.** This Resolution shall be effective upon adoption.
