

**RESOLUTION NO. 2025-R-233**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE A MAINTENANCE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND ENVISIONWARE, INC. FOR THE 24-HOUR LIBRARY KIOSK LOCATED AT 1525 N.W. 135 STREET, IN AN AMOUNT NOT TO EXCEED SIXTY-SEVEN THOUSAND DOLLARS (\$67,000.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on January 11, 2022, the City of North Miami (“City”) City Manager approved the purchase and installation of the EnvisionWare 24-Hour library kiosk, pursuant to the authority granted under Resolution 2021-R-81; and

**WHEREAS**, the EnvisionWare 24-Hour Library enables the City to provide the community with convenient access to library materials and services seven (7) days a week, twenty-four (24) hours a day; and

**WHEREAS**, EnvisionWare’s system allows users to check out and return materials, place and retrieve holds, download audiobooks and E-Books, and browse the main library catalog at any time, extending the reach of library services beyond standard operating hours; and

**WHEREAS**, City staff recommends approval of the proposed maintenance agreement with EnvisionWare to continue offering uninterrupted access to these valuable resources; and

**WHEREAS**, the proposed Maintenance Agreement ensures that the kiosk will remain operational, secure, and up-to-date with the latest software enhancements, including regular system diagnostics, software updates, hardware servicing, and remote technical support at a cost not to exceed Sixty-Seven Thousand Dollars (\$67,000.00); and


**WHEREAS**, the Mayor and City Council find that these services are essential to safeguard the City’s investment and to ensure seamless user experience for residents who rely on the 24-Hour Library for their educational needs, and hereby authorize the City Manager and City Attorney to negotiate and execute a maintenance agreement to the provision of these necessary services.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1.**     **Authorization to City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida hereby authorize the City Manager and City Attorney to negotiate and execute a maintenance agreement with EnvisionWare, Inc. For the 24-Hour Library Kiosk is located at 1525 N.W. 135 Street, at a cost not to exceed Sixty-Seven Thousand Dollars (\$67,000.00).

**Section 2.**     **Effective Date.** This Resolution shall become effective immediately upon adoption.
