

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE CITY MANAGER TO EXECUTE A
TWO-YEAR EXTENSION OF THE INTERLOCAL
AGREEMENT BETWEEN THE CITY OF NORTH MIAMI
AND MIAMI-DADE COUNTY FOR OFF-DUTY POLICE
SERVICES WITHIN THE SANS SOUCI SECURITY GUARD
SPECIAL TAXING DISTRICT, EXTENDING THE TERM
THROUGH NOVEMBER 5, 2027; PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) and Miami-Dade County (“County”) entered into an Interlocal Agreement (“Agreement”) on November 6, 2018, for the provision of off-duty police services within the Sans Souci Security Guard Special Taxing District; and

WHEREAS, the Agreement authorizes the City and the County to renew the Agreement for a successive two-year period upon mutual consent of the parties, allowing North Miami Police Officers to work security details at the Sans Souci Security Guard Special Taxing District at competitive off-duty rates, which include the appropriate administrative fees; and

WHEREAS, the County wishes to extend the Agreement for two (2) years with the existing terms and conditions, including the revised hourly rates effective April 1, 2023, in accordance with Modifications No. 1 to the Agreement; and

WHEREAS, the extension period will run from its current expiration date of November 5, 2025, through November 5, 2027, at 12:00 a.m.; and

WHEREAS, the Mayor and City Council find it in the best interest of the City and its residents to continue to provide police services to the Sans Souci Security Guard Special Taxing District and hereby authorize the City Manager to execute the attached Agreement extension with Miami-Dade County for this purpose.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The City Manager is hereby authorized to execute the two-year extension of the Interlocal Agreement, in substantially the attached form,

between the City of North Miami and Miami-Dade County for the provision of police services within the Sans Souci Security Guard Special Taxing District.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
