

**AMENDMENT TO
HOME INVESTMENT PARTNERSHIP PROGRAM
REHABILITATION LOAN AGREEMENT**

THIS AMENDMENT TO THE HOME INVESTMENT PARTNERSHIP PROGRAM (HOME) AGREEMENT ("Amendment") is entered into on _____, between the **City of North Miami**, a Florida municipal corporation with a principal address of 776 NE 125th Street, North Miami, Florida 33161 ("City"), **Building & Remodeling, Inc** ("Contractor") having its principal business address at 16515 SW 104 Court, Miami, FL 33157, and **Kendall Milord and Nehemie Milord** ("Owner") of the property located at 14145 NW 6 Avenue, North Miami, FL 33168. The City, Contractor, and Owner shall collectively be referred to as the "Parties".

RECITALS

WHEREAS, on October 6, 2025, the Parties entered into a Home Investment Partnership Program (HOME) Rehabilitation Program Agreement ("Agreement") which is attached hereto as Exhibit "A"; and

WHEREAS, the City desires to amend the Agreement to reduce rehabilitation services ("Services") as evidenced in the revised scope of services attached hereto as Exhibit A - Revised Scope of Work; and

WHEREAS, the Services amount was reduced by One Thousand Three Hundred Dollars and 00/100 (\$1,300.00).

NOW THEREFORE, in consideration of the mutual terms and conditions set forth below, the Parties agree as follows:

1. **Article 2** is hereby amended to reflect a total amount of Thirty-Six Thousand Seven Hundred and 00/100 Cents (\$36,700.00) in HOME funds being utilized for the rehabilitation of the subject property.
2. **Article 10** is hereby amended to reflect the ten (10) year affordability period, with forgiveness occurring in accordance with the Promissory Note executed by the Owner in favor of the City.
3. **Article 19** is hereby amended to reflect a limitation on liability amount of Thirty-Six Thousand Seven Hundred Dollars and 00/100 Cents (\$36,700.00).
4. **Exhibit A. SCOPE OF SERVICES** is hereby amended to show the modified requested services and total contract amount.
5. **Exhibit "C"**, Article 2, is hereby amended to reflect a total contract price of Thirty-Six Thousand Seven Hundred Dollars and 00/100 Cents (\$36,700.00)
6. All other terms and conditions of the Agreement remain in full force and effect.


