

**RESOLUTION NO. 2026-R-8**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING  
A SUBSCRIPTION AGREEMENT WITH FORCEMETRICS  
FOR A LAW ENFORCEMENT DATA ANALYTICS AND  
PERFORMANCE MANAGEMENT SOFTWARE  
SOLUTION FOR THE NORTH MIAMI POLICE  
DEPARTMENT IN AN AMOUNT NOT TO EXCEED  
NINETY-ONE THOUSAND NINE HUNDRED TWENTY-SIX  
DOLLARS (\$91,926.90); PROVIDING FOR AN EFFECTIVE  
DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the North Miami Police Department (“NMPD”) seeks to utilize a web-based application software platform that provides unified search capabilities, public safety data visualizations, and data linkages from multiple existing systems to support community impact analysis, operational efficiency, and performance measurement; and

**WHEREAS**, ForceMetrics is a public safety data platform that consolidates information from the City of North Miami’s (“City’s”) existing systems, including dispatch, records, and other databases, into a single interface designed to improve situational awareness, support informed decision-making, and enhance coordination among public safety partners; and

**WHEREAS**, the NMPD completed a ninety (90) day pilot program with ForceMetrics, and the results of the pilot demonstrated significant operational benefits; and

**WHEREAS**, the City and ForceMetrics entered into a Subscription Agreement effective August 1, 2025, which was fully executed on July 18, 2025, and which provides for a ninety (90) day proof-of-value period followed by automatic conversion to an annual subscription term unless timely notice of non-renewal is provided; and

**WHEREAS**, the total cost of the ForceMetrics project over a three-year period is \$91,926.90, funded through the General Fund, with anticipated costs of \$29,160.00 in Year One, \$30,618.00 in Year Two, and \$32,148.90 in Year Three, subject to annual budgetary appropriation; and

**WHEREAS**, the Mayor and City Council find it to be in the best interest of the City and its residents to ratify the executed Subscription Agreement and the associated multi-year funding commitment in order to memorialize and confirm the City’s contractual obligations.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification of Agreement.** The Mayor and City Council hereby ratify the Subscription Agreement between the City of North Miami and ForceMetrics for access to and use of its web-based software solution and standard support services, substantially in the form attached hereto as Exhibit "1".


**Section 2. Authority of City Manager.** The City Manager is authorized to take any and all actions reasonably necessary to effectuate the intent of this resolution, consistent with the terms of the Subscription Agreement.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
