

RESOLUTION NO. 2018-R-58

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO STAPLES CONTRACT AND COMMERCIAL, INC. D/B/A STAPLES ADVANTAGE, UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE, ON A CONTRACT AWARDED THROUGH THE NATIONAL JOINT POWERS ALLIANCE, AT A COST NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00) FOR THE PURCHASE OF OFFICE SUPPLIES; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) desires the purchase of office supplies (“Products”); and

WHEREAS, the National Joint Powers Alliance (“NJPA”) is a governmental purchasing cooperative with over fifty thousand (50,000) member agencies which establishes and provides nationally leveraged and competitively solicited purchasing contracts under the guidance of the Uniform Municipal Contracting Law; and

WHEREAS, on November 21, 2014, NJPA issued RFP No. 010615 “Office, School and Other Workplace-Related Supplies and Services” seeking responsive and responsible vendors to establish national contracts to provide quality office, school and other work related products, equipment and services; and

WHEREAS, Staples Contract and Commercial, Inc. d/b/a Staples Advantage (“Vendor”), was competitively selected by NJPA for the provision of office supplies, in accordance with the terms, conditions and specifications contained in the solicitation and was subsequently awarded Contract No. 010615-SSC through July 31, 2019; and

WHEREAS, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

WHEREAS, in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to execute purchase orders for the provision of Services, based on a competitive price to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Staples Contract and Commercial, Inc. d/b/a Staples Advantage, utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code, on a contract awarded through the National Joint Powers Alliance (“NJPA”), at a cost not to exceed Fifty Thousand Four Hundred Dollars (\$50,000.00) with the trade in of a surplus 2006 Freightliner Truck.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
