

RESOLUTION NO. 2018-R-88

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF METRO EXPRESS, INC., AS THE LOWEST-RESPONSIVE AND RESPONSIBLE BIDDER TO PROVIDE ALL LABOR, EQUIPMENT, MATERIALS, SERVICES AND EXPERTISE REQUIRED TO COMPLETE THE TRESSLER STREET DRAINAGE IMPROVEMENTS PROJECT, IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 27-17-18; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH METRO EXPRESS, INC., FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED EIGHT HUNDRED THIRTY-TWO THOUSAND FOUR HUNDRED SIXTY-NINE DOLLARS (\$832,469.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, on April 27, 2018, the City of North Miami ("City") advertised *Invitation for Bid No. 27-17-18 – Tressler Street Drainage Improvements Project* ("IFB"), as amended, seeking competitive bids from qualified, licensed and insured contractors to provide all labor, equipment, materials, services and expertise required to complete the Tressler Street Drainage Improvement Project on Northeast 17<sup>th</sup> Avenue from Northeast 16<sup>th</sup> Avenue to Northeast 135<sup>th</sup> Street (collectively referred to herein as "Services"), in accordance with the terms, conditions, and specifications contained in the IFB; and

**WHEREAS**, a total of twelve (12) bids were received in response to the IFB, from which Metro Express, Inc. ("Contractor") was found by City administration to meet the experience and qualification requirement under the IFB, and was therefore ranked as the lowest-responsive and responsible bidder for the provision of Services

**WHEREAS**, Contractor has manifested the capability and willingness of completing Services within one hundred eighty (180) days from the City's issuance of a Notice to Proceed, at a cost not to exceed Eight Hundred Thirty-Two Thousand Four Hundred Sixty-Nine Dollars (\$832,469.00); and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor, and authorize the City Manager and City Attorney to negotiate and execute an agreement for Services; and

**WHEREAS**, the Mayor and City Council find the selection of Contractor to be in the best interest of the City, and that the expeditious provision of Services are designed to protect the health, safety, and welfare of City residents.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Approving Selection of Contractor.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Metro Express, Inc., as the lowest-responsive and responsible bidder to provide all labor, equipment, materials, services and expertise required to complete the Tressler Street Drainage Improvements Project, in accordance with the terms, conditions and specifications contained in the *Invitation for Bid No. 27-17-18 – Tressler Street Draining Improvements Project*.

**Section 2. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with Florida Engineering & Development Corporation, for the provision of services in the amount not to exceed Eight Hundred Thirty-Two Thousand Four Hundred Sixty-Nine Dollars (\$832,469.00).

**Section 3. Effective Date.** This Resolution shall become effective upon adoption.
