

RESOLUTION NO. 2018-R-93

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE A THREE (3) MONTH EXTENSION TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND COUNTRY BILL'S LAWN MAINTENANCE, INC., FOR LAWN MAINTENANCE SERVICES, IN AN AMOUNT NOT TO EXCEED TWENTY THOUSAND EIGHT HUNDRED THIRTY-THREE DOLLARS (\$20,833.00) PER MONTH; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, the Professional Services Agreement for Lawn Maintenance Services between the City of North Miami ("City") and Country Bill's Lawn Maintenance, Inc. is due to expire on August 31, 2018; and

WHEREAS, as a result, the City issued Invitation for Bids ("IFB") No. 55-17-18 seeking proposals for lawn maintenance services; and

WHEREAS, bids were due on August 14, 2018 and the evaluation of bids is expected to be completed as expeditiously as possible; and

WHEREAS, to ensure that the City continues to have the resources available to perform the necessary lawn maintenance services, staff recommends the extension of the agreement with Country Bill's Lawn Maintenance, Inc. for a ninety (90) day period, with the extension term commencing September 1, 2018 and ending November 30, 2018; and

WHEREAS, expenditures will not exceed twenty thousand eight hundred thirty-three dollars (\$20,833.00) per month, for up to three (3) months; and

WHEREAS, the Mayor and City Council have determined that the continuation of Services from Contractor is in the best interest of the City and its residents.


NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney

to negotiate and execute a three (3) month extension to the Professional Services Agreement for Lawn Maintenance Services between the City of North Miami and Country Bill's Lawn Maintenance, Inc.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
