

RESOLUTION NO. 2018-R-99

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF FLOTECH ENVIRONMENTAL, LLC, AS THE LOWEST RESPONSIVE-RESPONSIBLE CONTRACTOR TO FURNISH LABOR, EQUIPMENT, MATERIALS, AND EXPERTISE REQUIRED TO COMPLETE SANITARY SEWER EVALUATIONS; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH FLOTECH ENVIRONMENTAL, LLC, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED ONE MILLION SIX HUNDRED FIFTY THOUSAND SEVEN HUNDRED TWENTY-FOUR DOLLARS (\$1,650,724.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 53-17-18 - SANITARY SEWER EVALUATIONS; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on May 25, 2018, the City of North Miami ("City") advertised *Invitation for Bid No. 53-17-18 - Sanitary Sewer Evaluations* ("IFB"), seeking competitive sealed bids from qualified licensed contractors to furnish all labor, materials, and expertise required to complete cleaning, inspection and evaluation of sanitary sewer lines, manholes and laterals within the service limits of the City of North Miami, in accordance with the specifications and conditions contained within the IFB (collectively referred hereto as "Services"); and

WHEREAS, in response to the IFB, Flotech Environmental, LLC ("Contractor") submitted its bid and was competitively selected by City administration as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City for an initial two (2) year term with three (3) additional one-year options to renew periods, at a cost not to exceed One Million Six Hundred Fifty Thousand Seven Hundred Twenty-Four Dollars (\$1,650,724.00), in accordance with the terms, conditions and specifications contained in the IFB; and

WHEREAS, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor and further authorize an agreement for the completion of Services; and

WHEREAS, the Mayor and City Council find the selection of Contractor to be in the best interest of the City, and that the provision of Services are designed to protect the public health, safety, and welfare.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Selection Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Flotech Environmental, LLC, as the lowest responsive-responsible contractor to furnish all labor, equipment, materials, equipment, and expertise required to complete sanitary sewer evaluations.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the stated services, in the amount of One Million Six Hundred Fifty Thousand Seven Hundred Twenty-Four Dollars (\$1,650,724.00) for an initial term of two (2) years with three (3) additional one-year options to renew, in accordance with the terms, conditions and specifications contained in *Invitation for Bid No. 53-17-18 - Sanitary Sewer Evaluations*.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
