

RESOLUTION NO. 2018-R-130

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS IN AN AGGREGATE AMOUNT NOT TO EXCEED FIVE HUNDRED FORTY THOUSAND DOLLARS (\$540,000.00) FOR A ONE (1) YEAR TERM FOR THE PURCHASE OF PUMPS, DRIVES AND MOTORS PARTS AND SERVICES, PIGGYBACKING MIAMI-DADE COUNTY CONTRACT NO. 6819-5/17-5; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on August 29, 2007, Miami-Dade County (“MDC”) issued Invitation for Bid No. 689-5/17 (“IFB”) requesting sealed bids from qualified vendors for the purchase of Pumps, Drives and Motors New and Rebuilt Units and Parks and Repair and Maintenance Services; and

WHEREAS, On April 8, 2008, MDC established a pool of pre-qualified vendors to supply units, parts, supplies and repairs for pumps, drives and motors; and

WHEREAS, on June 5, 2018, MDC extended the pre-qualification pool for an additional five (5) year term through July 31, 2023; and

WHEREAS, Section 7-167 of the City of North Miami (“City”) Code of Ordinances authorizes the City Manager to approve the purchase of supplies, goods and/or services from current agreements of other municipalities and governmental entities (“piggyback”), such as MDC; and

WHEREAS, City administration respectfully requests approval to piggyback MDC Contract No. 6819-5/17-5 for issuance of Purchase Orders in an amount not to exceed Five Hundred Forty Thousand Dollars (\$540,000.00) for a one (1) year term, to provide the City with pump, drives, and motors parts and services; and


WHEREAS, the Mayor and City Council find that the purchase of this equipment is in the best interest of the City and should be approved.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue a purchase orders in an amount not to exceed Five Hundred Forty Thousand Dollars (\$540,000.00) for a one (1) year term, to provide the City with pump, drives, and motors parts and services, piggybacking MDC Contract No. 6819-5/17-5.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
