

RESOLUTION NO. 2018-R-141

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF MAGGOLC, INC., AS THE LOWEST-RESPONSIVE, RESPONSIBLE CONTRACTOR TO FURNISH MATERIALS, EQUIPMENT, TOOLS, MACHINERY, SUPERVISION, EXPERTISE, AND SERVICES REQUIRED FOR THE INSTALLATION OF A TRAFFIC CIRCLE AT N.E. 4 AVENUE AND N.E. 127 STREET; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT FOR THE INSTALLATION OF A TRAFFIC CIRCLE AT THE SELECTED LOCATION, IN THE AMOUNT NOT TO EXCEED ONE HUNDRED SEVENTY-SEVEN THOUSAND ONE HUNDRED FIFTY-TWO DOLLARS (\$177,152.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 60-17-18; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on August 4, 2018, the City of North Miami ("City") advertised *Invitation for Bid No. 60-17-18 – Traffic Circle Project for N.E. 4th Avenue & N.E. 127th Street* ("IFB"), seeking competitive sealed bids from qualified licensed contractors to furnish all labor, materials, equipment, tools, machinery, supervision, expertise and services required for the installation of a traffic circle to be constructed at: NE 4th Avenue and NE 127th Street, in accordance with the terms conditions and specifications contained in the IFB (collectively referred hereto as "Services"); and

WHEREAS, in response to the IFB, Maggolc, Inc., ("Contractor") submitted its bid and was competitively selected by City administration as the lowest-responsive, responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City in the amount not to exceed One Hundred Seventy-Seven Thousand One Hundred Fifty-Two Dollars (\$177,152.00), within a period of one hundred twenty (120) days from the City's issuance of a Notice to Proceed ; and

WHEREAS, the Mayor and City Council, find the execution of an agreement with the Contractor, specifically for Services designed to protect the public health, safety, and welfare, is in the City's best interest.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Selection Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Maggole, Inc., as the lowest-responsive, responsible contractor to furnish materials, equipment, tools, machinery, supervision, expertise, and services required for the installation a traffic circle at N.E. 4th Avenue and N.E.127th Street.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the installation of a traffic circle at the selected location, in the amount not to exceed One Hundred Seventy-Seven Thousand One Hundred Fifty-Two Dollars (\$177,152.00), in accordance with the terms, conditions and specifications contained in Invitation for Bid No. 60-17-18.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
