The City of North Miami is an entitlement community eligible to receive assistance under the United States Department of Housing and Urban Development (HUD). The City of North Miami is anticipating an announcement from HUD regarding Fiscal Year (FY) 2019-2020 CDBG and HOME allocations. In accordance with the federal regulations, 24 CFR, Part 91, the City of North Miami is preparing a draft Annual Action Plan submission for its community development programs. This document is a requirement for direct assistance under HUD's funding programs including the Community Development Block Grant (CDBG), and HOME Partnership Investment Program (HOME). The city intends to submit the Annual Action Plan to HUD by August 15th, 2019.

The proposed FY 2019-2020 Annual Action Plan is a component of the 2015-2019 Consolidated Plan that identifies resources and strategies to assist with meeting housing and community development needs and includes plans for monitoring performance. The allocation amount for FY 2019-2020 is **\$757,246.00** in CDBG funds and **\$269,234.00** in HOME funds. CDBG and HOME funds will be used for public facilities, and infrastructure improvements, public services, affordable housing related projects, and economic development.

As part of the planning process, the City of North Miami is conducting public meetings to solicit public input on programs and activities eligible for CDBG and HOME funding and to prioritize such programs and activities for eligible areas citywide. Residents are invited to attend and participate in these discussions. The locations and dates of the meetings are as follows:
