PUBLIC NOTICE

The City of North Miami's (City) Community Planning and Development Department (CP&D) hereby notifies the public of the availability of funding for its 2018-2019 Affordable Housing Programs.

The City is an entitlement recipient of federal funds from the U. S Department of Housing and Urban Development (HUD) under the Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME) and State Housing Initiative Partnership Program (SHIP). For Fiscal Year (FY) 2018-2019, the City has received an allocation of \$1,057,586 through the CDBG and HOME programs, and \$51,922.00 through the SHIP program, a portion of which is designated by the City to assist income-qualified families. Funds will be used to develop stronger communities by providing decent housing, creating suitable living environments, and expanding economic opportunities, principally for people of low and moderate incomes.

Every year, the City opens registration to accept applications for the housing programs. Applications are accepted on a first-come, first-served, first-qualified basis, pending funding availability. This year, the City will propose an amendment to the Housing Program Guidelines to establish a new application time period accepting applications beginning October 1, 2018 through October 31, 2018, instead of September 1, 2018, to provide additional time for submittals. In addition, the City will propose a new lottery process that will eliminate the first-come, first-served, first-qualified criteria.

This amendment to the Housing Program Guidelines will be heard at the City Council Meeting on September 25, 2018 at 7:00pm in the Council Chambers, 776 NE 125 Street, North Miami, FL 33161. Persons wishing to comment on the proposed amendment may submit written comments beginning August 24, 2018 to September 24, 2018 at the Community Planning and Development located at 12400 NE 8th Ave, North Miami, FL. 33161 or at the North Miami Public Library located at 835 NE 132nd St, North Miami, FL 33161.
