



**CONSOLIDATED ANNUAL PERFORMANCE EVALUATION REPORT
(CAPER – FY 2017-2018 –October 1, 2017 thru September 30, 2018)**

In accordance with HUD regulations at 24 CFR 91.520, the Community Planning & Development Department must submit its performance report to HUD within 90 days after the close of the program year. Thus, the City of North Miami Community Planning & Development department has prepared a draft of the FY 2017-2018 Consolidated Annual Performance Evaluation Report (CAPER), which will be submitted to the HUD Office (909 SE 1 Ave. Room 500 Miami, FL 33131-3042) on or about December 28, 2018. The FY 2017-2018 CAPER (draft) covers the period from October 1, 2017 to September 30, 2018 and contains reporting information on community development activities pursuant to the requirements of 24 CFR Part 91, including but not limited to a description of the progress the City of North Miami has made in carrying out its Five Year Consolidated Plan, Annual Action Plan, Actions to Further Fair Housing, and status of funds.

In addition, the regulations at 24 CFR 91.105 require a public comment period of not less than 15 days. Therefore, the citizens are given until December 27, 2018 at 5pm to forward their written input, views and comments on the FY 2017-2018 CAPER (draft copy) to the Community Planning & Development Office. A summary of citizen comments (if any) relating to activities reported in the FY 2017-2018 CAPER will be included in the final document for its submission to HUD.

The FY 2017-2018 CAPER (draft) will be available for public review and comment at the Community Planning & Development Office at (12400 NE 8th Avenue, North Miami, FL 33161) and at The City of North Miami Library (835 NE 132nd Street, North Miami, FL 33161) starting on December 12, 2018 until December 27, 2018.
