

RESOLUTION NO. 2019-R-134

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE NON-EXCLUSIVE PUBLIC TRANSPORTATION SERVICES AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND LIMOUSINES OF SOUTH FLORIDA, INC., TO PROVIDE FOR AN EXTENSION TO THE TERM ON A MONTH-TO-MONTH BASIS FOR A PERIOD NOT-TO-EXCEED THREE (3) MONTHS; PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on November 25, 2014, the City of North Miami (“City”) entered into a non-exclusive public transportation services agreement (“Agreement”) with Limousines of South Florida, Inc. (“Contractor”) in accordance with the terms, conditions and specifications contained in the City’s *Request for Proposal No. 48-12-13, Community Transportation Services* (“RFP”); and

WHEREAS, Contractor provides public transportation services at designated local transit routes within the City of North Miami (“Services”); and

WHEREAS, on November 15, 2017, the City executed a renewal to the Agreement extending the term through November 25, 2019; and

WHEREAS, the City is currently soliciting proposals from qualified, licensed and experienced firms to provide fixed-routes passenger transit services and to ensure sufficient time for the selection, award and transition of services under the replacement agreement, City staff recommends an extension beyond November 25, 2019; and

WHEREAS, to ensure that NOMI Express continues to operate while the replacement contract is being finalized, staff recommends that the Mayor and City Council approve this request to extend Contract No. 48-12-13 on a month-to-month basis, under the same terms and conditions, for a period not-to-exceed three (3) months; and

WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the City Manager and City Attorney to negotiate and execute an Amendment to the


Agreement to allow for the continuous provision of community transportation services during the solicitation and transition period.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an Amendment to the non-exclusive public transportation services agreement between the City of North Miami and Limousines of South Florida, Inc.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
